
4-H DEPT: They will be using Membership cards and will be taking in 4-H entries on Saturday and Sunday.

Goals of the Anne Arundel County Fair

To serve as a showcase for ingenuity, talent and interest in the agricultural life.

To serve as a means of educating children and young people to the honorable profession of farming, including the handling of animals from birth to market, the growth, preparation and preservation of food and the creativity of home arts skills.

#### ARTICLE I- MEETING OF MEMBERSHIP

#### SECTION 1.....MEETINGS:

Membership meetings shall be held the third Tuesday of January, April, June, August, **October** and November. The November meeting shall serve as the corporate meeting and Election of Officers. Membership meetings will be held at 7:30 PM at the Fair Office unless otherwise stated or informed by mail/email or telephone. (Amended 8/11/2020).

#### SECTION 4......VOTING:

Any person Only members who have not paid their dues for the current membership year by on or before January 20th, will not be considered a member for the purpose of voting for the calendar year. A majority plurality of votes will determine election to office. (Amended 8/2022).

#### SECTION 8......INSTALLATION:

The installation of Officers and Board of Directors shall be in the month of January. All membership dues by the individuals elected must be paid by January 1 prior to the installation of Officers and Board of Directors at the January membership meeting. (Amended 8/19)

Section 8a.....OATH OF OFFICE: Any Officer or Director at their installation must execute the following Oath of Affirmation: To the office which you were duly elected: Do you solemnly swear (or affirm) that you will faithfully promote, protect, execute and enforce the goals, bylaws, policies procedures and membership of the Anne Arundel County Fair, Incorporated for the duration of your elected term. (Amended 8/19).

#### **ARTICLE II- DIRECTORS**

#### SECTION 5.....BOARD OF DIRECTORS

The Board of Directors shall establish and maintain a "Lawn Equipment Upgrade Account". All Fair corporate Events shall be taxed 5% of their net profits and these used exclusively funds for the purchase of "upgraded" or "new "lawn maintenance equipment. (Amended 8/15)

#### SECTION 5A......DIRECTORS' MEETINGS:

Monthly meetings of the Board of Directors are to be held. Time and place will be determined by the Board of Directors. Special meetings of the Board may be called by the President upon written/email request of five (5) Directors. (Amended 8/18)

#### **SECTION 12.....SPECIAL ACCOUNTS**

#### **SECTION 12A: EMERGENCY & CORPORATE REAL ESTATE FUND**

The Board of Directors shall establish and maintain an "Emergency and Real Estate Account" All Fair corporate events shall be taxed 5% of their net profits and these funds put into the escrow account. In a "State of Emergency", monies may be duly withdrawn after a three fourths majority vote by the Board of Directors. Monies may be used for the purchase of a permanent site for the corporation and its activities. (Amended 4/10)

**SECTION 12B: LAWN EQUIPMENT UPGRADE ACCOUNT** 

The Board of Directors shall establish and maintain a "Lawn Equipment Upgrade Account". All Fair corporate Events shall be taxed 5% of their net profits and these funds used exclusively for the purchase of "upgraded" or "new "lawn maintenance equipment. (Amended 8/15)

#### **ARTICLE III- OFFICERS**

#### SECTION 3......DUTIES OF OFFICERS:

The duties and powers of the Officers of the Anne Arundel County Fair, Inc. shall be as follows:

#### PRESIDENT:

- The President shall preside at all meetings of the Board of Directors and Membership meetings.
- They shall present at the November Membership meeting a report of the conditions of the business of the Fair association.
- The President shall appoint the Fair Week Event Manager, subject to the approval of the Board. They shall appoint such subordinate managers, assistants and committees as they find necessary to manage the business of the Fair. (Amended 8/18).
- They shall appoint and remove, employ and discharge, and fix the compensation
  of all servants, agents, employees and clerks of the Anne Arundel County Fair,
  Inc., other than duly appointed Officers, subject to the approval of the Board of
  Directors.
- They shall see that the books, reports, statements, and certificates required by the statutes are properly kept, made and filed according to law.
- They shall sign and make all contracts and agreements related to the operations of the Fairgrounds in the name of the Anne Arundel County Fair, Inc.
- They shall sign all notes, drafts or bills of exchange, warrants or other orders for the payment of money duly drawn by the Treasurer.
- They shall enforce these Bylaws and perform all the duties incident to the position and office, and which are required by law.
- They shall have the power to declare a "State of Emergency" in the event of an unforeseen or natural disaster and coordinate the emergency response plan as needed. (Amended 8/21).

#### **ARTICLE V- MEMBERSHIP**

#### SECTION 6......HONORARY MEMBERS:

Presented by the President with the approval of the Board of Directors, Recipient of the Honorary Membership will be entitled to lifetime privileges of a regular member, right to one (1) vote, to serve as a Director or Officer, free entrance into the Anne Arundel County Fair for two (2), and serve on committees. The Honorary Member (s) will be recognized at the Annual Volunteer Dinner for the calendar year. In the event there is no volunteer dinner, the presentation will be at the last General membership meeting of the calendar year. The President will present the member (s) with a certificate and membership card. No dues are to be paid,

however, the Honorary Member is required to renew their membership notice with the Membership Committee each year. (Amended 8/98).

#### **ARTICLE VIII- COMMITTEES**

SECTION 1......STANDING COMMITTEES:

The President shall with the consent of the Board of Directors, appoint the following standing committees of the Corporation:

#### Fair Week:

- Chaired by the appointed Fair Week Event Manager.
- The Fair Week Event Manager will manage all aspects of the Fair Week Event.
- The Fair Week Event Manager may create a Fair Week Committee to assist in the operations of the Fair Week Event.
- The Fair Week Event Manager will create subcommittees and appoint chairpersons.
- The Fair Week Event Manager or appointed chairpersons will write and sign contracts related to the Fair Week Event held annually on the fairgrounds.

#### **POLICIES**

- 21. The Rental Committee will have to check with the Fair **Week** Event **Manager** Chairpersonfor new rentals/events one week prior to or after Fair sponsored events. (Amended 11/13/18).
- 26. Operating Fair Equipment (Tractors, Mowers, Golf Carts, etc...) Only persons with a valid driver's license are allowed to drive the Fair's riding equipment and **N**o renters are allowed to use the equipment. This equipment is to be used for fair business only. (Adopted 8/19/04). 26a. Persons 18 years and over:
  - 1. It is recommended, but not required, to have a valid driver's license
  - 2. The person must be a Fair member or a registered volunteer of the Anne Arundel County Fair, Inc.
  - The person MUST have approval from the Fair President and the equipment manager or grounds manager (Approval between managers and president can be done by phone if not all are present)
  - If while operating equipment, it should break, it is recommended to help the maintenance manager with the repair, unless the equipment manager deems it not necessary. (Amended 4/30/2013).
  - 26b. Persons under the age of 18, but over the age of 16:
    - Sixteen (16) and Seventeen (17) year olds are required to have a valid driver's license.

- 2. Must have permission from parents or guardians to operate equipment.
- During the open hours of operation of Fair sponsored events the person WILL NOT be allowed to operate equipment in areas that the general public has access to. (Amended 4/30/2013).
- 4. Must attend a Tractor and Machinery Safety Course.

26c. Renters of Fairgrounds: No renter is allowed to drive fair equipment. (Amended 4/30/2013)

- 27. Adoption of the new Fair logo for all Fair advertising, etc. (Adopted 7/13/04).
- 28. Reserve Officer Donations: Set the donation for the Reserve Officers in accordance with the Fair Week agreement and which will go into effect Fair Week 2006. (Added 6/13/06).
- 29. Allow BGE to use the fairgrounds as a staging area for their equipment during an area disaster. (Adopted 6/19/07).
- 30. To preserve the integrity of the election held at the annual membership meeting in the month of November, no fair member on the ballot, nor family members of one's on the ballot, will be allowed to tally the votes. (Adopted 10/8/19).
- 31. The Bylaw Committee Chair has the ability to make formatting and grammatical changes to the Bylaw and Policies document as long as the structure and meaning of the Bylaw or Policy is not affected. (Adopted 8/10/21).
- 32. The Anne Arundel County Antique Tractor Club will be allowed to store equipment on the fairgrounds for longer than 30 days without said property becoming fair property. This equipment is utilized for various fair sponsored events and used to help maintain fair property.
